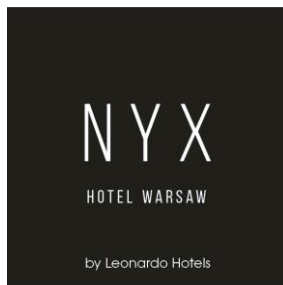
In accordance with the Regulation of the Council of Ministers of December 21, 2020, we would like to inform you that the NYX Hotel Warsaw is open to the following groups of guests from 15/03/2021 to 03/05/2021:

- 1) with regard to the operation of workers' hotels or hotels for seasonal workers
- 2) for medical professionals
- 3) for aircraft crew members
- 4) for persons performing work or providing services on ships or offshore extraction and drilling platforms, based on a relationship other than a seafarer employment contract;
- 5) for drivers engaged in road transport;
- 6) for train crew members
- 7) for employees of the railway infrastructure manager employed in positions directly related to the operation and safety of railway traffic and the operation of specific types of railway vehicles
- 8) for persons performing professional activities in the field of public investment implementation outside the place of permanent residence;
- 9) for employees of entities ensuring business continuity of critical infrastructure, including the provision of traction current and liquid fuels for railway undertakings;
- 10) for patients and their guardians in order to obtain healthcare services in an entity performing medical activities;
- 11) for guests who are officers or soldiers of: the Armed Forces of the Republic of Poland, the Police, the Border Guard, the Internal Security Agency, the Foreign Intelligence Agency, the Central Anticorruption Bureau, the Military Intelligence Service, the Military Counterintelligence Service, the Customs and Treasury Service, the State Fire Service, the State Protection Service, The Prison Service, the Road Transport Inspection and the railway security guards, in connection with the performance of their official tasks;
- 12) for persons who carry out in the Republic of Poland or a neighbouring country work related to the preparation or implementation of investments in the field of oil terminals
- 13) for players, coaches and members of the training staff using these services during training camps or sports competition; 14) for candidates and other persons involved in organizing and conducting an examination confirming qualifications in an occupation or a professional examination;
- 15) for legal representatives, defenders and representatives of the parties, parties to criminal, civil and court-administrative proceedings, their statutory representatives, witnesses, experts and court interpreters, on the day of the court session or review of the case files and on the preceding day;
- 16) for members of diplomatic missions, consular offices and representatives of international organizations and their family members, as well as other persons who are holders of a diplomatic passport in connection with the performance of their official functions.
- 17) for employees of enterprises implementing investment projects in the Republic of Poland, which received support under the Act of 10 May 2018 on supporting new investments on the

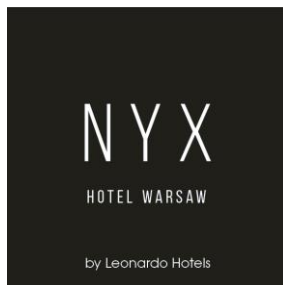

- 18) for guests who are soldiers of allied forces, temporarily staying in the Republic of Poland;
- 19) for civilian employees of the Armed Forces of the Republic of Poland, the Police, the Border Guard, the Internal Security Agency, the Foreign Intelligence Agency, the Central Anti-Corruption Bureau, the Military Intelligence Service, the Military Counterintelligence Service, the Customs-Tax Service, the State Fire Service, the State Protection Service, the Prison Service, Road Transport Inspection and railway security guards, in connection with the performance of professional tasks outside the place of permanent residence
- 20) for persons providing inspection, maintenance or repair services of medical equipment and apparatus or technical infrastructure, including technical devices, in connection with the performance of professional tasks or business activities related to these services outside the place of permanent residence;
- 21) for employees serving airports and air traffic, in connection with the performance of professional tasks
- 22) for persons directly involved in the preparation of content used by broadcasters holding a license referred to in Art. 33 paragraph. 1 of the Act of December 29, 1992 on radio and television broadcasting in connection with the performance of professional tasks or business activities related to the preparation of content used by these broadcasters;
- 24) for foreigners unable to continue their travel to the place of permanent residence or stay;
- 25) for civil aircraft passengers in cases of denied boarding, cancellation or long delay of flights;
- 26) staff of the European Border and Coast Guard Agency (Frontex);
- 27) participating in the competition for judicial training and prosecutor's training, including applications conducted in the form of supplementary applications, as well as those taking the judge's exam and the prosecutor's exam, and other persons participating in the organization and conduct of these competitions and examinations
- 28) persons providing inspection, maintenance or repair services for machines and devices used in agri-food processing plants in connection with the performance of professional tasks or business activities related to these services outside the place of permanent residence;
- 28) sports judges, whose presence is necessary for the implementation of sports
- 29) doping control persons
- 30) journalists who work outside their place of residence (with a press ID);
- 31) for members of committees and teams responsible for bar, legal adviser and notary exams, bailiff, entrance exams for attorney, solicitor, notary and bailiff training, and an exam for applicants for a restructuring advisor license, as well as for participants in the preparation and organization of these exams,

32) for members of examination committees conducting examinations related to the resulting rights regulations on road transport, drivers of vehicles, transport of dangerous goods, technical supervision in connection with the performance of official tasks 33) for members of the State Commission for Investigation of Maritime Accidents, State Commission for Investigation of Air Accidents and the State Commission for Investigation of Railway Accidents during accident investigations or incidents.

Confirmation needed for the Hotels:

- 1) practicing the medical profession is a document issued by the entity performing the medical activity;
- 2) the circumstances referred to in **points 3–9, 17 and 23** is a document issued by that person's employer,
- 3) the circumstances referred to in **point 10**, is a referral or other document confirming that the patient is to be provided with healthcare;
- 4) performing the official tasks referred to in **point 11 and 18**, is an official ID card;
- 5) performing the work referred to in **point 12, 19, 21 and 22**, is a document issued by the employer;
- 6) the fact of a grouping or sports competition referred to in **point 13**, is a document issued by the entity paying the sports salary or scholarship or by an international sports federation operating in Olympic or Paralympic sports, or other recognized by the International Olympic Committee or an international sports organization with a range continental belonging to such a federation, or a Polish sports association;
- 7) the circumstances referred to in **point 14** a document issued by the headmaster of the school or educational institution, the employer, the regional examination board or the Central Examination Board;
- 8) the circumstances referred to in **point 15** notification or other document confirming the court session or the disclosure of the case file;
- 9) performing the official functions referred to in **point 16**, there is a document issued by the competent Ministry of Foreign Affairs confirming this fact;
- 10) the circumstances referred to in **point 24** are the foreigner's declaration,
- 11) the circumstances referred to in **point 25** shall be a document issued by the air carrier
- 13) the circumstances referred to in **point 26** business card / ID
- 14) the circumstances referred to in **point 27**, a document issued by the director of the educational institution, the employer, the regional examination board or the Central Examination Board;
- 15) the circumstances referred to in **point 28**, a document issued by the employer
- 16) the circumstances referred to in **point 29-33**, an ID or a document issued by the employer
